



# REVOLVING LAND CONSERVATION PROGRAM (RLCP) – MANITOBA

Through the RLCP, Ducks Unlimited Canada purchases land, restores the wetlands and uplands on the property when it makes sense to do so, and then sells the land back to agricultural producers with a conservation agreement placed on the title as a condition of the sale. Proceeds from the sale provide DUC with funds to purchase additional land to continue this cycle of habitat conservation.

### G+S BOLDUC PROJECT – SE15-4-22 WPM

- + Located in the RM of Deloraine-Winchester, 12 miles north-northeast of Deloraine
- + 160 acres on title (71.8 acres non-arable land, 88.2 acres arable)
- + Conservation agreement is **No Drain No Fill** on 71.63 non-arable acres

### WHETTER PROJECT – NW11-5-23 WPM

- + Located in the RM of Grasslands, six miles south of Hartney, one mile west of Highway 21 on Road 26N
- + 160 acres on title (71 acres unfenced tame grass/legume mix sown in 2018, 89 acres non-arable)
- + Conservation agreement is **No Break No Drain with 10-Year Rejuvenation**. No restrictions on timing of haying/grazing.

## UPCOMING RLCP PROPERTY SALES

*These properties have been purchased under the RLCP program and are being developed (restoring wetlands; seeding tame forage) prior to advertising the properties for sale.*

### ROBMAR PROJECT – S ½ 24-16-26 WPM

- + Located in the RM of Prairie View, seven miles south-southeast of Birtle on Road 93N
- + 286.17 acres on title (197 acres unfenced tame grass/legume mix sown in 2019; 89.17 acres non-arable)
- + Conservation agreement type will be **No Break No Drain with 10-Year Rejuvenation**. No restrictions on timing of haying/grazing.
- + Anticipated to be advertised for sale in spring of 2020

### EASTCOTT PROJECT – SECTION 4-18-23 WPM

- + Located in the RM of Yellowhead, five miles north of Shoal Lake on Highway 21 between Roads 102N and 103N

- + 633.31 acres on title (258 acres native/natural pasture. fenced; 233 acres to be sown to tame forage in 2020; 13 acres restored wetlands; 129.31 acres wetlands and associated grassland)
- + Conservation agreement type will be **No Break No Drain with 10-Year Rejuvenation**. No restrictions on timing of haying/grazing.
- + Anticipated to be advertised for sale in the fall of 2020

### JACKSON PROJECT – E ½ 35-6-28 WPM

- + Located in the RM of Two Borders, four miles south-southwest of Reston at Road 36N and 163W
- + 330 acres on title (218 acres to be sown to tame forage in 2020; seven acres restored wetlands; 105 acres wetlands and associated grassland)
- + Anticipated to be advertised for sale in fall 2020; conservation agreement type will be **No Break No Drain with 10-Year Rejuvenation**

## TYPES OF CONSERVATION AGREEMENTS ON RLCP LANDS

### No Drain No Fill

- + Wetlands are protected from draining and filling but may be cropped through when dry

### No Break No Drain

- + Wetlands are protected from breaking and draining and grassed upland areas are protected from breaking.

### No Break No Drain with 10-Year Rejuvenation

- + Same as No Break No Drain, with added ability to rejuvenate tame forage acres every 10 years.
