

# REVOLVING LAND CONSERVATION PROGRAM

The Revolving Land Conservation Program (RLCP) is an opportunity for landowners to purchase land for their own operational needs and to support conservation. Land that is part of the RLCP program will have areas of wetlands and grassland protected by a no-break-no-drain conservation easement (CE) but can still be used for grazing, hay production or for recreational purposes. Proceeds from RLCP land sales go back into DUC programs to fund further conservation work. **RLCP land is an ideal fit for cattlemen and is compatible with waterfowl production.**
