

OFFICIAL RAFFLE RULES AND CONDITIONS:
Ducks Unlimited Canada Saskatchewan Council – Online 50/50 (“Raffle”)

OFFICIAL RULES: By participating, entrants agree to be bound by these Official Rules and by the decisions of **Ducks Unlimited Canada Saskatchewan Council**, which shall be binding and final as to all matters related to the Raffle. The Raffle is operated under Provincial Lottery License No. **RR20-0037** and is subject to all applicable federal, provincial and local laws.

NET PROCEEDS: All net proceeds of the Raffle will benefit **Ducks Unlimited Canada Saskatchewan Council**, (hereafter known as “Sponsor”) and the programs that Sponsor supports. Ducks Unlimited Canada Saskatchewan Council is a National non-profit corporation with a mission to conserve, restore and manage wetlands and associated habitats for North American waterfowl. These habitats also benefit other wildlife and people. Registered charitable organization tax number: **11888957 RR0001**

PRIZES: Winner will receive 50% of the Total Raffle Sales. (“Prize”)

ELIGIBILITY TO ENTER: During the dates and times and other details specified below, raffle tickets are available for purchase by anyone 18 years and older, while located in Saskatchewan, regardless of their residence.

Fundraising Staff of Ducks Unlimited Canada Saskatchewan Council are not allowed to purchase tickets or win a prize for this raffle.

PURCHASING RAFFLE ENTRIES: The following prices and corresponding “ticket numbers” are available for purchase: **1 ticket for \$10, 10 tickets for \$20, and 50 tickets for \$50**

Raffle tickets will be available for purchase by eligible persons online at <https://www.ducks.ca/> beginning July 15th, 2020 and concluding August 15, 2020.

Purchasers must provide their first name, last name, address, telephone number and e-mail as part of the purchase process and must purchase tickets with a valid credit card (Visa, MasterCard, American Express) via a secure payment gateway

NUMBER OF RAFFLE TICKETS: A maximum of 2,000 sets of tickets with a maximum 35,500 tickets will available to be sold. The maximum value of ticket sales is \$50,000 with a maximum prize payout of \$25,000 with the following price levels and ticket sets:

500 sets of 1 ticket for \$10 1000 sets of 10 tickets for \$20 500 sets of 50 tickets for \$50

THE DRAWS: The potential winner will be selected with a certified Random Number Generator. The draw will be made at the Ducks Unlimited office on August 16th, 2020 at 10:00am at 300 - 3530 Millar Ave, Saskatoon SK. S7P 0B6

The winning number will be posted online at: <https://www.ducks.ca/> Additionally, the winner will be contacted via telephone per the information they submit at time of online purchase.

The winner will have 365 Calendar days to claim their prize. If a prize is not claimed after the 365 days has expired, Ducks Unlimited Canada Saskatchewan Council will donate the unclaimed prize

money to a charitable beneficiary approved by SLGA in accordance with SLGA Raffle Terms and Conditions Sec 13 (d)

DETERMINATION OF OFFICIAL WINNER(S): Sponsor shall have the sole discretion to determine whether each Potential Winner is an official winner of a Prize (an “Official Winner”). Sponsor’s decision concerning the identity of all Official Winners shall be final and binding. To become an Official Winner: (1) a Potential Winner must be eligible to participate in the Raffle under these Official Rules and must not be in violation of these Official Rules as determined in Sponsor’s sole judgment; (2) that Potential Winner must claim the prize by the deadline specified above.

The winner must provide his/her name, address and phone number with picture identification to claim the prize. A scan of a valid provincial or federal photo identification card (i.e., driver’s license, firearm possession permit, passport, etc.) is acceptable.

AWARD OF PRIZE(S) TO OFFICIAL WINNER(S): A Prize will be awarded to the Potential Winner who has been designated by Sponsor as an Official Winner. All prizes will be awarded to the Winner via cheque. For security and safety reasons, no cash payments will be made to winners. The winner’s name will be published.

GENERAL CONDITIONS: The Released Parties (defined below under “RELEASE OF LIABILITY”) are not responsible for: (1) Entries which are stolen, lost, damaged, illegible, given away or no longer in the purchaser’s possession, (2) Entries that have been or may have been tampered with or re-sold in violation of these Official Rules; (3) Entries or payments that are delayed, misdirected, undelivered, not fully captured, or garbled as a result of any failure or problem whatsoever with the availability, functionality, operability or use of any network, server, ISP, website, computer, telephone, cable or satellite modem or connection, hand held mobile device or any other computer equipment or connection, whether or not caused by site users, tampering, hacking, or by viruses, worms, or malfunctions affecting a network, server ISP or any equipment or programming used in or associated with the Raffle; (4) any other errors of any kind, whether human, typographical, printing, mechanical, or electronic in nature, which relate to or are connected with the Raffle (collectively, as described in clauses (1) through (4), “Errors”), including without limitation Errors in Raffle-related materials or in the administration of the Raffle, such as Errors in processing Entries, identifying Potential Winners, determining Official Winners, or announcing or delivering Prizes; or If any portion of the Raffle is compromised, in Sponsor’s sole judgment, by a virus, worm, bug, non-authorized human intervention or other causes which, in Sponsor’s sole judgment, corrupt or impair the administration, security, fairness or proper play of the Raffle, or the proper submission or capture of Entries (collectively, a “Compromising Event”), then Sponsor reserves the right, in its sole discretion, to suspend, modify or terminate the Raffle, and to select winners from all eligible, non-suspect Entries received before the known occurrence or discovery of such Compromising Event. All Entry purchases shall be final, and no refunds or replacements will be issued by Sponsor. Sponsor has sole and final decision on admissibility of entries and the determination of prize winner.

RELEASE OF LIABILITY: Entrants, by participating in the Raffle, agree that The Sponsor and Tap 50:50, each of their respective parents, affiliates, subsidiaries, partners, and advertising and promotion agencies, and all of their respective officers, directors, employees, representatives, shareholders, members, consultants and agents (collectively, the “Released Parties”) will have no liability whatsoever for, and shall be held harmless by entrants against, any liability for injuries, losses, cost, expenses or damages of any kind, including damages for death, personal injury, property damage.
