

2021 Ducks Unlimited Canada Manitoba Provincial Council Conservation Calendar Raffle

Rules of Play/Rules and Regulations

1. Ducks Unlimited Canada (DUC) is a national non-profit corporation with a mission to conserve, restore and manage wetlands and associated habitats for North American waterfowl. These habitats also benefit other wildlife and people. Registered charitable organization tax number: 118888957 RR0001.
2. Raffle is operated under **License #LGCA 7062-RF-34718**; and is subject to the gaming laws of the Province of Manitoba. Tickets cannot be purchased by, for or on behalf of persons under 18, or by DUC Manitoba Fundraising staff members. Ticket sales must take place within Manitoba. Persons visiting from out of province may purchase a ticket if the entire transaction of payment and receipt of ticket occurs while the person is in Manitoba.
3. Raffle is titled: "2021 Ducks Unlimited Canada Manitoba Provincial Council Conservation Calendar Raffle."; Purchasers have the opportunity to win "-a gun a week-" and a one-time cash prize. **Ticket sales close on December 17th, 2020 at 6:00 p.m. CST.**, or once all calendars are sold. All draws will be made on December 18th, 2020 at 10:00 a.m. CST at the Ducks Unlimited Canada office (1 Mallard Bay, Stonewall, MB, R0C 2Z0). Every ticket holder has the right to and will be able to attend the drawing if they choose. Fifty-two random draws will be held with prizes awarded in order as illustrated in the calendar. All winner's will be notified on a weekly basis by phone or email beginning January 6th, 2021 and ending on December 29th, 2021. Winners will be posted on the website at www.ducks.ca/ManitobaConservationCalendar and on our Facebook Page @ducmanitobafundraising. The 53rd Draw will be the \$10,000 one-time cash prize payout (via cheque from DUC) and the winner will be notified December 18th, 2020 by phone and/or email as provided on their entry form.
4. All prizes are firearms classified as non-restricted long-guns under the Criminal Code of Canada. Total retail value of all prizes is \$71,682.00(CDN\$) which includes the one-time cash prize of \$10,000(CDN\$). Four Thousand (4000) calendars will be printed and available for sale; 53 prizes will be awarded which includes the one-time cash payout. Odds of winning: 1-in-75. After each draw is made that ticket will go back into the draw drum and will be eligible to be re-drawn.
5. Firearms are printed on the calendar each week with each model's description on the selected week; images displayed may not accurately portray actual model of firearm. A complete list of the raffle prizes and the rules of play can be found within the calendar.
6. Calendars/tickets are \$50.00 each. Cash, personal cheque, credit cards or debit cards (where/when available) are accepted for the purchase of the calendars. If a personal cheque is returned NSF, purchaser is subject to additional fee of \$40.00 and/or disqualification from the raffle. Raffle tickets (calendars) may be purchased from Manitoba DUC Volunteer representatives and/or at DUC sanctioned events/tradeshows. Tickets (calendars) may also be ordered by telephone at 1-800-665-3825, or by emailing mbconservationcalendar@ducks.ca. In the matter of telephone and/or email orders, buyers must provide all information as required on the lottery ticket stub and purchase by credit card transaction; a ticket (calendar) will be mailed to the purchaser at no charge. Entries received that are deemed illegible (unreadable), and/or do not contain enough information to contact a potential winner, will be declared ineligible and removed from the draw; no refund will be issued. No tickets may be purchased after the-

ticket sales closing date of December 17th, 2020 at 6:00 p.m., CST.

7. **Winners, to claim their prize, must produce within 9 Months from date of winner announcement, a valid, current Canadian Possession and Acquisition License (PAL) or Canadian Possession Only License (POL);** information will be submitted to the Ducks Unlimited Canada Associated Distribution Centre for processing. Upon confirmation and acceptance of the license information by the Canadian Firearms Centre, the firearm will be shipped at no charge, directly to the winner at the address on file with the Canadian Firearms Centre. All firearms are purchased through Stoeger Canada and warehoused at the DUC Associated Distribution Centre for processing and shipping.
8. **In the event the winner(s) cannot produce within 9 Months a valid, current PAL or POL, the firearm will be returned to Ducks Unlimited Canada (DUC) for the purpose of drawing a new winner for that prize item.** Sufficient effort will be made to contact the winner(s) in a timely manner based on the contact information provided on the information portion of the ticket page. Onus is on the purchaser to provide legible and accurate contact information.
9. Name and information, given on the information part of the ticket page, must match/be the same as the name and information associated with the PAL/POL given at the time of claiming the prize. No exceptions will be permitted.
