At times there may be DUC contractors and staff working on the property that could affect access to the property.

1	Big Sand Bay	Located in Prince Edward County Lat./Long. 43.924589, -76.926749	Accessible by boat only. Access off Big Sand Bay. Permission not required, but visitors should follow general guidelines as listed above.
2	Cameron Swamp	Located in Lennox and Addington County, near Kingston Lat./Long. 44.44900700, -76.8449790	Accessible by canoe via Camden Lake (crown land). Permission not required, but visitors should follow general guidelines as listed above.
3	Carp Hills	Located in Carp, near the City of Ottawa Lat./Long. 45.370000, -76.050000	Accessible by foot. Please contact DUC for hunting permission, rules and guidelines: ontario@ducks.ca or 705-721-4444
4	Cornell Island (Clark Island)	Located in the Town of Greater Napanee Lat./Long. 44.182804, -76.928496	Accessible by boat from the Bay of Quinte. Permission not required, but visitors should follow general guidelines as listed above.
5	Howe Island	Located in the Township of Frontenac Islands, near Kingston Lat./Long. 44.286215, -76.256427	Accessible by boat or canoe from Johnson Bay. Hunting permitted in water or from shoreline only. Permission not required, but visitors should follow general guidelines as listed above.
6	Jubilee Point	Located in the Township of Otonabee-South Monaghan, near Peterborough Lat./Long. 44.156172, -78.241547	Accessible by boat from Rice Lake. Permission not required, but visitors should follow general guidelines as listed above.
7	Mud Creek	Located in the Township of Laurentian Valley, near Pembroke Lat./Long. 45.686454, -77.038375	Accessible by foot or canoe from south side of Ross Road. Permission not required, but visitors should follow general guidelines as listed above.
8	Muskrat Island	Located in the Township of Otonabee-South Monaghan, near Peterborough Lat./Long. 44.192304, -78.180386	Accessible by boat from Rice Lake. Permission not required, but visitors should follow general guidelines as listed above.
9	Robillard	Located in the Township of South Dundas, near Cornwall Lat./Long. 45.007879, -75.152539	Accessible by foot or canoe from south side of Colquhoun Road. Property is on the south side of the bridge. Permission not required, but visitors should follow general guidelines as listed above.
10	St. Luke's Marsh	Located in the Municipality of Chatham-Kent, adjacent to the St. Clair National Wildlife Area Lat./Long. 42.378206, -82.412422	Accessible by boat only. Permits are required September to January and can be booked online at www.longpointwaterfowlers.ca
