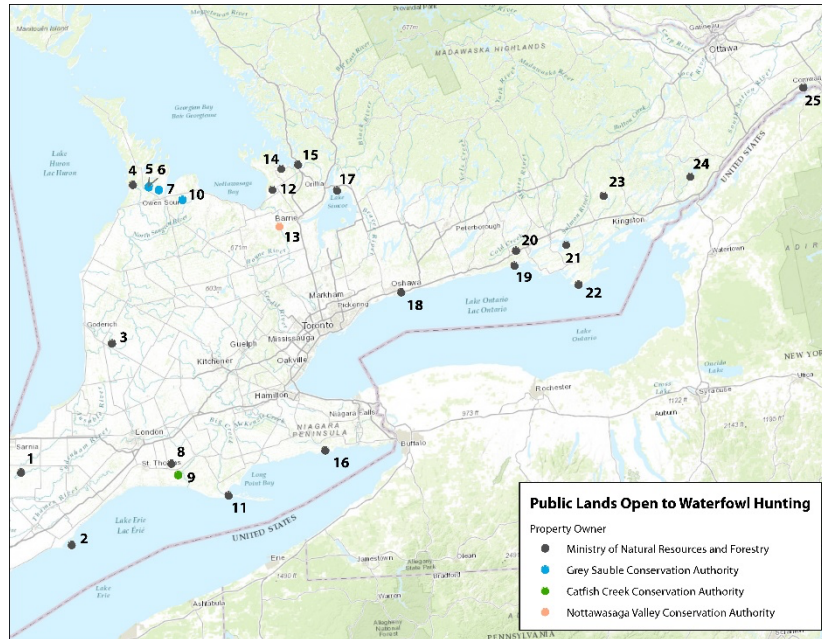


Public and Privately-owned Properties in Ontario
