## Rules and Regulations ("Rules")

## 1. How to Participate

- 1.1 The sponsor of this sweepstakes is Ducks Unlimited Inc. and Ducks Unlimited Canada (collectively referred to as "D.U." below). The prize providers are Ducks Unlimited Inc., Ducks Unlimited Canada, Chene Gear, onX and Drake Waterfowl.
- 1.2 Eligibility: The "Waterfowl Season Outlook" sweepstakes (the "giveaway") is open to all legal residents of the United States of America (excluding residents of Minnesota, Montana, New York, Texas and Washington), and Canada (excluding residents of Québec), age 18 years of age or older (or at least the age of majority as legally mandated by the entrant's jurisdiction of residence if greater than 18) at date of entry. - 1.4 Giveaway Entry: By completing the giveaway entry form, using the link provided during the Waterfowl Season Outlook live virtual event on YouTube and ducks.ca, qualifying individuals will be entered into the draws. No purchase or donation is required.

- 2.4 Notification of Selection: Eligible winners will be contacted via email at least three (3) times within the fourteen (14) days after the draw. If an eligible winner does not respond in that time, another entrant will be randomly selected, and the initial eligible winner will be disqualified and will have no recourse toward D.U., or anyone involved in the giveaway. In order to win, the eligible winner will be required to sign a Declaration and Release Form confirming compliance with the Rules, acceptance of the prize as awarded and releasing D.U., or anyone involved in the giveaway, from all liability relating to the giveaway.
